AFFIDAVIT OF [REDACTED]

1. I, [REDACTED], being duly sworn, state the following is true and accurate to the best of my knowledge.
2. That I was born and raised on the Big Island of Hawaii.
3. That I am a temporary resident of 13-3775 Pahoa Kalapana Road, Pahoa, HI 96778 Sate of Hawaii.
4. That I am a friend of Dr. Lenard Horowitz and Sherri Kane who I understand is the owner of this residence at 13-3775 Pahoa Kalapana Road, Pahoa, Hawaii 96778. Dr. Leonard Horowitz and Sherri Kane are both truthful and loving individuals who constantly and fearlessly serve humanity against all corruption.
5. That I make this affidavit on my own free will and that I have not been paid or coerced by Dr. Leonard Horowitz and Sherri Kane, to make this sworn statement.
6. That Dr. Horowitz and Sherri Kane has not paid me to live on this estate.
7. That I make this affidavit solely because on September 20th 2013, I became aware that three (2) Notices to Vacate and (3) Trespass Warnings were left on the front gate and presented to me by another resident of the property by the name of Todd Swain who told me he had taken these notices off the front gate of the property. A copy of the notices is attached.
8. As a result of reading these notices I became paranoid and suspicious that the Notice to Vacate was a covert scare tactic to threaten tenants who live here to vacate without honest legal due process.
- ~~9. At the time and still now I wondered if the Notice to Vacate were lawful because it was not signed by any known Sherriff or Police officer according to the local Police department.~~
10. The Notice to Vacate did have a lawyer on it by the name of Phillip Carey and that he also represents Jason Hester who is the counter party who is trying to claim ownership to Dr. Len Horowitz and Sherri Kane's property. Dr. Leonard Horowitz and Sherri Kane have also shown me audio transcriptions of Phillip Carey clearly admitting that he is in fact working together with Paul J. Sulla Jr. This audio transcript and recording of Phillip Carey was also provided as additional evidence by Dr. Len Horowitz and Sherri Kane and filed with the Police Department as far as I know.
11. A Police report was filed on September 20th 2013 by Officer K. Kobayashi who filed the report of this Notice to Vacate. I let the police officer know that I have seen a copy of the Official Sate of Hawaii issued property Warranty Deed which lists "THE ROYAL BLOODLINE OF DAVID" a Washington non profit corporation controlled and owned by

Exhibit "WW".

Dr. Len Horowitz as the Warranty Deed GRANTEE. I showed the Warranty Deed to the Police and will provide it for the record. I also have seen further receipts and documents showing Dr. Leonard Horowitz and had made several balloon payments for the foresaid property.

12. It is my understanding from Dr. Horowitz and Sherri Kane that these Notices to Vacate not only came from Phillip Carey but mainly Attorney Paul J. Sulla, Jr.

13. Dr. Leonard Horowitz and Sherri Kane also emailed me a handwriting analysis comparing Paul J. Sulla Jr.'s hand writing in contrast to the supposed writing of the Process Server Officer "R DUM" on the (2) Notices to Vacate which I believe did show several similarities between Paul J. Sulla Jr.'s handwriting and the so called Process Server Officer "R DUM" on the Notices to Vacate.

14. A key note is that the original State of Hawaii Warranty Deed property conveyance clearly defines the GRANTOR: LORAN LEE, also known as C. Loran Lee, single, whose mailing address is 13-3775 Pahoia Kalapana Highway, Pahoia, Hawaii 96778 who was the last owner of the property entirely and completely conveyed the property and everything on it to the GRANTOR: "THE ROYAL BLOODLINE OF DAVID" a Washington non profit corporation, whose mailing address is P.O. Box 1739, Newport, Washington 99156 controlled and owned by Dr. Len Horowitz.

15. The same night of the Notice to Vacate [REDACTED] and I heard a gun shot nearby in the forest at night so we felt like our lives may be in danger wondering if that was some sort of warning shot although we also wondered if it could be hunters but we were obviously suspicious about the timing being that it happened on the same day the Notice to Vacates and Trespass Warning signs were posted.

16. As a result of reading the Notices to Vacate we do not feel safe or secure staying at Dr. Leonard Horowitz and Sherri Kane's property. Also because Paul J. Sulla Jr. and Phillip Carey are lawyers I am afraid to speak about the truth and facts that I have witnessed which clearly shows that the "The Royal Bloodline of David" was fully conveyed the foresaid property according to the Official Warranty Deed and that I have not seen any documented evidence disproving this yet.

17. Additionally many years ago I became aware through many members of the Honokaa Community that there was a Santo Daime Ayahuasca Church who people say was controlled and owned by Paul J. Sulla Jr.

18. I cannot recall the exact date but around 2006 I attended the so called Santo Daime Ayahuasca Church with [REDACTED]. When we arrived everyone was requested to wear white shirts and black or blue pants and the men would stand on the south west side and the Women would stand on the north east side.

19. The traditional South American beverage Ayahuasca, or yage, is derived by boiling the ayahuasca vine (*Banisteriopsis caapi*) with leaves of one or more plants containing

DMT, such as *Psychotria viridis*, *Psychotria carthagenensis*, or *Diplopterys cabrerana*.^[9] The Ayahuasca vine contains harmala alkaloids,^[94] highly active reversible inhibitors of monoamine oxidase A (RIMAs),^[95] rendering the DMT orally active by protecting it from deamination. 20. To my recollection, Paul J. Sulla Jr. and his son Joseph Sulla as well as other Church members sang songs in Portuguese while other songs were sung in English. Everyone would line up and drink the Santo Daime Ayahuasca in opposing female and male lines a few times throughout the entire night into the early dawn around maybe 2am to 3 am into the next morning. The whole session maybe lasted around 8 hours.

21. I have met both Paul Sulla Jr and his son Joseph Sulla a few times over the years in public and during their Ayahuasca Church ceremonies and we were always mutually friendly to each-other. I have been to their Ayahuasca Santo Diame Church a few times and I respect their practice and beliefs as I respect anyone's practice and beliefs. I believe the Ayahuasca drink they provided me was a mind and emotional activating and somewhat healing experience that was beneficial for my self at that moment in time.

22. The repetitive song and dance that was performed in the Church when I was there was exhausting it is not what I wanted to be doing while I was on Ayahuasca especially when there was no direct explanation of why we would sing specific songs and dance repetitively for so many hours. When the Ayahuasca hit me the natural feeling was to go outside to communicate with nature and be one with nature. The Ayahuasca by itself was something that I personally enjoyed and learned from but it wasn't something I chose to continue doing regularly mainly because of the Church setting, I would simply prefer to have done it alone in nature to have freedom and space away from anyone.

23. They would usually mention that there was always a required donation I believe of at least \$25 which I recall paying which members stated went towards the preparation of the Ayahuasca drink.

24. Dr. Leonard Horowitz and Sherri Kane notified and showed me this website <http://www.biopark.org/peru/ayahuasca-krippner.html> which states "Joseph Sulla is a psychology student who has taken courses at the University of California, Santa Cruz, and the University of Hawaii. He has made five expeditions to various ayahuasca centers in Brazil including Ceu do Mapia, where he learned about Santo Daime traditions, participated in ceremonies, and studied local herbalism and Umbanda with Madrinha Maria Alice Freire. Sulla's fieldwork resulted in much of the historical material appearing in this article".

25. I feel that Paul J. Sulla Jr. and Joseph Sulla should offer informed consent to all of their members including anyone that's invited to their Church if they are conducting research or studies on the effects of Ayahuasca on anyone. Being totally transparent to everyone they invite is extremely important so everyone is fully aware of all research that

may be being conducted including providing detailed information of all the known health risks of using Ayahuasca and DMT. Reading the article above accompanied by the known risks of Ayahuasca has caused enough concern for me and my community that I felt compelled to come forward about their Ayahuasca Church as well.

26. Elder Shamans who I have met who teach ancient awakening and healing modalities have warned me anyone who takes Ayahuasca regularly which contains DMT and other strong Harmala alkaloids, can cause irreparable damage to the mind, and body which can negatively affect or damage the spiritual awakening process.

27. I feel that all Ayahuasca and DMT use should be transparently researched under informed consent to anyone who chooses to experience or research its effects as well as that the entire process should be fully open to public input so everyone understands what the effects and health risks are. I think that Ayahuasca and DMT has valuable information that should be researched for humanity's evolution but that there should be high levels of educational information provided to everyone who seeks to learn about how it affects the human mind, body, and spirit and that all the research information should not be used, abused, or manipulated in anyway shape or form by any entity, organization, individual, or government.

28. Finally I hope and pray that the truth is recognized and that Dr. Len Horowitz and Sherri Kane are provided honest due process and justice within the legal systems to help them protect their rights and their land.

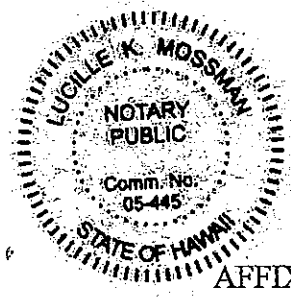

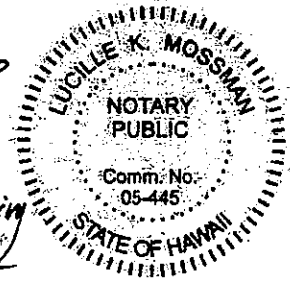

14. I also met Paul J. Sulla's son Joseph Sulla at this Ayahuasca "church" event. He was leading the ceremony at the Ayahuasca "church" event were I went with [REDACTED]
15. I did not feel comfortable at this Ayahuasca "church" event and departed.

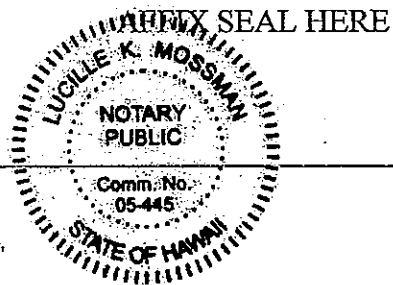
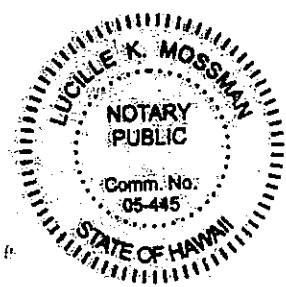
